

RESOLUTION NUMBER R-274995

ADOPTED ON JANUARY 16, 1990

WHEREAS, on Tuesday, January 16, 1990, the Council requested a reconsideration of action taken by the City Council on January 24, 1989 (Item No. 331); and


WHEREAS, the public health, safety, and welfare would be served by this reconsideration request; and

WHEREAS, it is necessary to place the matter on the docket under Special Order of Business and, by the affirmative vote of at least six members of the City Council, suspend Permanent Rule of Council No. 34 (Council Policy 000-06) and thereafter vote upon reconsideration and set a date for consideration thereof; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that in the matter of reconsideration of action taken by the City Council on January 24, 1989 (Item No. 331) in respect to denying the request of Frederick and Raymond Hampe for a hearing of an appeal of the Planning Commission's denial of Vesting Tentative Subdivision Map No. 87-0115, Hampe Hills and accompanying rezoning case No. 87-0115 from A-1 10,000 to OSP and R-1 5,000 (HRD) located at the southerly terminus of La Trutch Street between Stargaze Avenue and Rotherham Way within the Penasquitos East Community Planning Area, the Council hereby waives the Permanent Rule of Council No. 34 (Council Policy 000-06) and grants reconsideration of the action taken by the City Council on January 24, 1989 (Item No. 331).

BE IT FURTHER RESOLVED, by the Council of The City of San Diego, that the hearing on the merits will require a thirty (30) day notice period and be docketed for the Council agenda on February 27, 1990.
