APPROVING PARCEL MAP W.O. NO. 880688.


BE IT RESOLVED, by the Council of The City of San Diego, that said Council hereby finds that certain map surveyed by Ronald C. Parker, Licensed Land Surveyor, PARCEL MAP W.O. NO. 880688 being a map of Lots A-224 and portions of A-225 and A-226 of Addition No. 5 to San Ysidro, in the City of San Diego, County of San Diego, State of California, according to amended map thereof No. 1405, filed in the office of the County Recorder of San Diego County, January 2, 1912, together with a portion of Vista Lane, as dedicated to public use," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: a portion of South Vista Avenue, and said portion of a street is hereby declared to be a portion of a public street and dedicated to the public use, as dedicated and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said portion of a street is accepted on

behalf of the public as heretofore stated, all as granted and shown on the map within this subdivision is accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said map to the County Recorder of the County of San Diego, California.
