BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with Black & Veatch, Engineers-Architects, for design services in connection with Point Loma Wastewater Treatment Plant Sedimentation Basins 11 and 12, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- 275013, together with any reasonably necessary modifications or amendments thereto which do not increase project scope or cost and which the City Manager shall deem necessary from time to time in order to carry out the purposes and intent of this project and agreement.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer an amount not to exceed \$771,581 within Sewer Revenue Fund No. 41506 from CIP No. 46-111.0, Rose Canyon Trunk Sewer, to CIP No. 46-134.0, Point Loma Sedimentation Basins 11 and 12.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$1,603,581 from Sewer Revenue Fund No. 41506, CIP No. 46-134.0, Point Loma Sedimentation Basins 11 and 12, is hereby

authorized, solely and exclusively for the purpose of providing funds for the above project.
