BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is authorized to transfer unexpended budgeted funds, if any, to the appropriate reserves upon the advice of the administering department.

BE IT FURTHER RESOLVED, that the City Manager is authorized and directed to amend the City's 1988 Community Development Block Grant Program Statement to include development of a recreational center facility at the San Ysidro Athletic Area (Larsen Field).
