BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with EDWARD C. WUNDRAM, Architect, for professional advisory services in connection with the Balboa Park Organ Pavilion parking garage design competition, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- 275016, together with any reasonably necessary modifications or amendments thereto which do not increase project scope or cost and which the City Manager shall deem necessary from time to time in order to carry out the purposes and intent of this project and agreement.


BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$350,000.00 from Fund No. 102242, CIP No. 21-834, is hereby authorized, to be expended as follows: \$148,650.00 for purposes of the above agreement; \$162,250.00 for conduct of the design competition; and \$39,100.00 for miscellaneous related costs of this project.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer excess budgeted funds, if any,

to the appropriate reserves upon advice of the administering  
department.
