BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$41,331.10, consisting of \$17,511.10 from Water Revenue Fund No. 4101, Wastewater Systems Construction Program, Annual Allocation for Water Main Replacements (CS No. 73-198); \$23,820.00 from Water Revenue Fund No. 4101, Wastewater Systems Construction Program, Annual Allocation for Sewer Main Replacements (CS No. 73-198); and \$0.00 from Water Revenue Fund No. 4101, Wastewater Systems Construction Program, Annual Allocation for Sewer Main Replacements (CS No. 73-198) is hereby authorized.
