WHEREAS, Councilmember Abbe Wolfsheimer requested that an item be placed on the January 17, 1990 Rules Committee agenda to permit consideration for support of S. 11 (Cranston) and H.R. 780 (Levine), entitled "The California Desert Protection Act"; and

WHEREAS, the Rules Committee did not have the opportunity to address the matter and the Chair forwarded it to the full Council for consideration; and

WHEREAS, that Act provides a long term plan to protect California's unique desert ecology while accommodating the needs and concerns of recreational vehicle users, mining and agricultural interests; and

WHEREAS, Intergovernmental Relations Department (IRD) Report No. 90-2, dated January 10, 1990 explains in detail the provisions of the Act as proposed by the legislators; and

WHEREAS, it is recommended that the Council approve the recommendation to support S. 11 (Cranston) and H.R. 780 (Levine);

NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council, for and on behalf of the people of San Diego, does hereby support S. 11 (Cranston) and H.R. 780 (Levine), entitled "The California Desert Protection Act" as recommended in IRD Report No. 90-2, dated January 10, 1990.

BE IT FURTHER RESOLVED, that the Director of Intergovernmental Relations Department be and she is hereby directed to advise the City's Washington, D.C. legislative representative and San Diego's congressional delegation of this support for the proposed Act.


