That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

Jeffrey Jacobson	City Treasurer	\$853.26	Mr. Jacobson is a Clerical Assistant II in the Parking Citations Section of the City Treasurer's Office. He suggested changing the process for preparing cases for court docket. The new procedures save time, improve accuracy, and require fewer forms. His suggestion is expected to save \$5,688.41 in time and material during the first year. This is a partial award, pending a 12-month review.
William Wehrung III	Fire	\$500.00	Mr. Wehrung is a Fire Fighter in the Fire Department. He suggested combining the oxygen regulator unit and the trauma box, using a nylon bag container. Although savings are difficult to identify, this is considered to be a significant operational improvement.
Lawrence Hamilton	City Attorney	\$500.00	Mr. Hamilton is a Litigation Investigator in the City Attorney's Office. He suggested using the Police Department's aerial support unit to photograph accident scenes, when needed, instead of hiring a private company for this service. This is expected to save \$22,770.81 in time and material during the first year. Mr. Hamilton is a Category II suggester and is eligible for a maximum award of \$1,000. This is a partial award, pending a 12-month review.
