Item 1 - The low acceptable bid of MUSTANG EQUIPMENT COMPANY for furnishing TWO (2) EACH TOW COMPRESSORS at a cost of \$9,801.00 each, for a total cost of \$19,602; terms net 30 days plus sales tax.

Item 2 - The low bid of MUSTANG EQUIPMENT COMPANY for furnishing NINE (9) EACH SKID COMPRESSORS at a cost of \$8,459.00 each, for a total cost of \$76,131.00; terms net 30 days plus sales tax.
