
ADOPTED ON FEB 5 1990

BE IT RESOLVED, by the Council of The City of San Diego, that the Auditor and Comptroller is hereby authorized to establish a new special revenue fund (102402), for the purpose of administering the Commercial Facade Improvement Rebate Program in Ocean Beach, Mid-City and Golden Hill.

BE IT FURTHER RESOLVED, that the transfer of an amount not to exceed \$60,000 from the Industrial Development Revenue Bond Administrative Expense (10240) Fund to the 102402 Fund, for the purpose of funding the Rebate Program for Ocean Beach, Mid-City and Golden Hill, is hereby authorized in the manner and as described in the attachment hereto which is by this reference incorporated herein.
