

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with Foster Engineering, Inc. for professional services in connection with fire suppression systems in the Museum of Man, Museum of Art, Museum of Natural History, and Casa de Balboa, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR-275085, together with any reasonably necessary modifications or amendments thereto which do not increase project scope or cost and which the City Manager shall deem necessary from time to time in order to carry out the purposes and intent of this project and agreement.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$30,000.00 from the Transient Occupancy Tax
Unappropriated Reserve for Balboa Park Improvement Projects, Fund
No. 102242, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.



BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer unexpended funds, if any, to the appropriate reserves upon advice of the administering department.
