A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING CENTRE CITY DEVELOPMENT CORPORATION TO ACT ON BEHALF OF THE CITY FOR THE CONSTRUCTION OF A DAY CENTER FOR THE HOMELESS IN THE CENTRE CITY AREA.

WHEREAS, the Redevelopment Agency of The City of San Diego (the "Agency") is engaged in activities necessary to carry out and implement the redevelopment plans for the Horton Plaza,

Marina, Columbia and Gaslamp Quarter Redevelopment Projects; and

WHEREAS, the Redevelopment Agency has authorized Centre City
Development Corporation to carry out and implement the
redevelopment plans for the Horton Plaza, Marina, Columbia and
Gaslamp Quarter Redevelopment Projects on behalf of the Agency;
and

WHEREAS, The Council of The City of San Diego has determined that Centre City Development Corporation is the appropriate entity to implement construction of a Day Center for the Homeless; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego as follows:

- 1. That the Council hereby authorizes Centre City

 Development Corporation on behalf of the City to receive bids for
 the construction of a Day Center within the Centre City Area.
- 2. That the Council hereby authorizes the City Manager (or his designee) to award the contract to the lowest qualified

bidder provided said bids are within the established budget for the construction of such public improvement.

- 3. That the construction contract shall not exceed \$732,000 from the C.I.P. 39-106, Fund No. 19619.
- 4. That the Council hereby authorizes Centre City

 Development Corporation on behalf of the City to administer said

 contract.
- 5. That the Council hereby amends Capital Improvement Program 39-106 by increasing the amount by \$517,000, bringing the total amount to \$842,000 and accepts funds in the amount of \$117,000 from the Regional Task Force for the Homeless and \$400,000 from the Agency to fund the increased amount.
