RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN DIEGO, SOLE MEMBER OF THE CENTRE CITY DEVELOPMENT CORPORATION, INC.

WHEREAS, the Board of Directors of the Centre City

Development Corporation, Inc. has previously voted to amend its

Articles of Incorporation to restrict the irrevocable dedication

of its property and assets in order to preserve its entitlement

to exemption from property taxes; and

WHEREAS, Centre City Development Corporation,... Inc. has requested the approval of said amendments by the sole member of the Corporation, the City of San Diego, acting by and through its City Council; NOW, THEREFORE,

BE IT RESOLVED, that the City Council of The City of San Diego, acting as the sole member of the Centre City Development Corporation, Inc., hereby approves an amendment to revise Article II, Section 6 in its entirety to read as follows:

This Corporation is and shall be a nonprofit corporation without capital stock or shares, and it is a corporation which does not contemplate pecuniary gain or profit to the member, officers or directors thereof or to any private person. This Corporation is organized and formed exclusively for charitable purposes and all property of this Corporation is irrevocably dedicated to such use.

And further, approves an amendment to revise Article IV in its entirety to read as follows:

The property of this Corporation is irrevocably dedicated to charitable purposes and no part of the net income or assets of this organization shall inure to the benefit of any private persons. Upon the dissolution or winding up of the Corporation, its assets remaining after payment or provision for payment of all debts and liabilities of this Corporation shall be distributed to the City of San Diego, to be used solely for charitable purposes, or if the City of San Diego does not accept the assets or is not then in existence, to a nonprofit fund, foundation, or corporation which is organized and operated exclusively for charitable purposes and which has established its tax exempt status under Section 501(c)(3) of the Internal Revenue Code.
