RESOLUTION NUMBER R- 275129

ADOPTED ON FEB 12 1990

WHEREAS, due to development, substantial losses of habitat areas and fragmentation of remaining areas is occurring in San Diego and such losses and fragmentations pose a threat to the biological resources of San Diego; and

WHEREAS, development has also severed connections between habitat areas resulting in small, isolated habitat areas which are subject to species extinctions over time, with no possibility of recruitment from adjacent areas; and

WHEREAS, such small isolated areas of natural vegetation are less valuable resources than larger habitat areas; and

WHEREAS, large, connected systems are needed in order to preserve representative plants and animals with high species diversity; and


WHEREAS, habitat acquisition funds could be used for acquisition, maintenance, and administrative costs associated with the development of such habitat preserves; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Auditor and Comptroller be and he is hereby authorized and directed to establish an interest bearing trust account to be entitled "Habitat Acquisition Fund" for the purpose of serving as a repository for funds contributed to the City for acquisition, maintenance, and administrative costs associated with the establishment of biological habitat preserves.

BE IT FURTHER RESOLVED, that the Planning Director or the Director's designee be and are hereby designated as the administrators of said fund.
