That the Mayor and City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, a copy of which is on file in the office of the City Clerk as Document No. RR-275146, quitclaiming to AMERICAN NEWLAND ASSOCIATES, all

of the City's right, title and interest in the water easement in all that portion of Section 29, Section 30 and Section 31, Township 14 South, Range 3 West, San Bernardino Meridian, as more particularly described in the quitclaim deed.

3. That the City Clerk shall cause both deeds, and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder, the easement deed recorded at no fee, for the benefit of the City, with no documentary tax due.
