BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of the City, an agreement with Almgren & Koptionak, Inc., for consulting services in connection with the La Jolla-Pacific Beach trunk sewer, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- 275153, together with any reasonably necessary modifications or amendments thereto which do not increase the project scope or cost and which the City Manager shall deem necessary from time to time in order to carry out the purposes and intent of this project and agreement.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer a sum not to exceed \$178,745.00 within the Sewer Revenue Fund (41506), Sewer Construction Outlay (70492), from CIP No. 43-093.0, Island Avenue Sewer Interceptor, to CIP No. 46-164.0, La Jolla-Pacific Beach Trunk Sewer.

BE IT FURTHER RESOLVED, that the expenditure of a sum not to exceed \$516,745.00 from the Sewer Revenue Fund (41506), CIP No. 46-164.0, La Jolla-Pacific Beach Trunk Sewer, is hereby authorized, solely and exclusively to provide funds for the above project.
