WHEREAS, The City of San Diego supports the efforts of the community and the San Diego Unified School District to retain students in compensatory education programs; and

WHEREAS, some students require special attention and enhanced educational programs to reduce their risk of dropping out of school; and

WHEREAS, the San Diego Private Industry Council and Regional Employment Training Consortium (PIC/RETC) is applying for a grant from the Department of Labor, entitled "Youth Opportunities Challenge Grant;" and

WHEREAS, this grant will be used to establish a "High School Redirection Program" designed to meet the needs of these students "at risk" of permanently dropping out of school; and

WHEREAS, PIC/RETC has developed partnerships with other organizations concerned about the education, health and wellbeing of our City's children; and

WHEREAS, these partnerships will support the activities and goals of the "Redirection" program established by PIC/RETC following the award of the grant; and

WHEREAS, the City Council supports and encourages these partnerships and the establishment of the "High School Redirection" program; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council, for and on behalf of the people of San Diego, hereby endorses the efforts of the San Diego Private Industry Council and Regional Employment Training Consortium to gain the Youth Opportunities Challenge Grant from the Department of Labor and encourages PIC/RETC to establish the "High School Redirection" program upon award of the grant.
