Stacy Silverwood	Fire	\$2,500.00	Mr. Silverwood is a Fire Engineer in the Fire Department. He suggested automation of the Employee Performance Reports for probationary firefighters. This is expected to save \$17,114.36 in time during the first year. This is a partial award pending a twelve-month review.
Jeffrey Jacobson	City Treasurer	\$ 624.00	Mr. Jacobson is a Clerical Assistant II in the Parking Citations Section of the City Treasurer's Office. He suggested modification of the DMV registered-owner printout to include only information used by the Treasurer's Office. This is expected to save \$4,160.00 in material during the first year. This is a partial award pending a twelve-month review.
