WHEREAS, late in the afternoon on January 18, 1990, Frank Huang and Robert Partridge were walking down their street in High Country West when they witnessed a robbery in progress; and

WHEREAS, the lone occupant of the house being burglarized was a blind sixteen year old, who was a school friend of Frank and Robert; and

WHEREAS, the two Mt. Carmel High School freshman responded to this incident by memorizing the license number of the fleeing vehicle, one staying with the occupant of the house while the other called the Neighborhood Watch Block Captain; and

WHEREAS, the details relayed to the Neighborhood Watch Captain were then forwarded to the San Diego Police Department who subsequently broadcast the information over their frequencies; and

WHEREAS, late that evening in National City, police were able to apprehend two suspects of the High Country West robbery; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council, for and on behalf of the people of The City of San

Diego, does hereby commend Frank Huang for his proper and quick response in reacting to a burglary in his community.
