BE IT RESOLVED, by the Council of The City of San Diego that the low bid of REACH ALL, meeting specifications, is hereby accepted and the City Manager is hereby authorized to execute a contract for the purchase of TWO (2) VAN MOUNTED AERIAL TOWERS (Reach All P6 Van with LM40 Tower) at a cost of \$81,751.00 each, for a total cost of \$163,502.00; terms net, plus sales tax.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$175,355.90 (\$87,677.95, from Department No. 8201, Fund No. 50031, Account No. 6013 and Job Order No. 88090), and (\$29,810.50, from Department No. 8201, Fund No. 50031, Account No. 6013 and Job Order No. 88070), and (\$57,867.45 from Department No. 8203, Fund No. 50033, Account No. 6013 and Job Order No. 88070), is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
