

BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for CONSTRUCTION OF TRAFFIC SIGNAL AND STREET LIGHTING SYSTEMS AT 3RD AVENUE AND UNIVERSITY AVENUE.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$86,500.00 from CIP NO. 68-010.0 ANNUAL ALLOCATION - CONSTRUCT TOP 10-15 PRIORITIZED TRAFFIC SIGNALS, Proposition "A" Fund 30300, authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller to retain excess monies, if any, in CIP No. 68-010.0 ANNUAL ALLOCATION - CONSTRUCT TOP 10-15 PRIORITIZED TRAFFIC SIGNALS.
