WHEREAS, the playground equipment will provide a positive enhancement to Linda Vista Community Park and the field trips will fulfill the request most received by the recreation center; and


WHEREAS, this donation continues the generous financial support by the Gleichs to the City of San Diego; NOW, THEREFORE,
