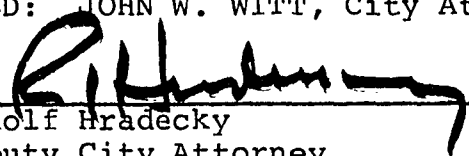
BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, the First Amendment to the agreement of February 16, 1989 with Lusk Construction Company, in connection with the construction of a parking lot at Tierrasanta Community Recreation Center, under the terms and conditions set forth in the First Amendment on file in the office of the City Clerk as Document No. RR- 275199, together with any reasonably necessary modifications or amendments thereto which do not increase project scope or cost and which the City Manager shall deem necessary from time to time in order to carry out the purposes and intent of this project and amendment.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$231,489.00 from Fund No. 30244, CIP No. 23-590.1, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer any excess budgeted funds to the appropriate reserves upon advice of the administering department.
