ADOPTED ON FEBRUARY 26, 1990

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an amendment to an agreement with SAN DIEGO COUNTY CERTIFIED DEVELOPMENT CORPORATION, a copy of which is on file in the Office of the City Clerk as Document No. RR-275203-1, to carry out the Community Development Block Grant (CDBG) Program within the City of San Diego, under the terms and conditions set forth in the Agreement on file in the Office of the City Clerk as Document No. RR-272557-1.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed ninety-four thousand two hundred and ninety dollars (\$94,290.00) from CDBG Fiscal Year 1989 Fund 18525, is hereby authorized, solely and exclusively for the purpose of providing funds for the execution of the amendment to the agreement with the San Diego County Certified Development Corporation.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to extend the existing agreement for Certified Development Corporation monitoring with George Peterson & Associates from January 1, 1990, to June 30, 1990, a copy of which is on file in the Office of the City Clerk as Document No. RR-275203-2, and that the City Auditor and Comptroller is hereby authorized to expend six thousand and sixty dollars


