

RESOLUTION NUMBER R-275213

ADOPTED ON FEBRUARY 26, 1990

WHEREAS, on March 24 and 25, 1990, the Children's Hospital Auxiliary (the "Auxiliary") will be conducting a fundraiser (the "Event") for Children's Hospital in the San Diego Jack Murphy Stadium (the "Stadium") parking lot; and


WHEREAS, when food and novelties are sold at such events, the Stadium receives a standard thirty percent (30%) of the gross food concession and ten percent (10%) of gross novelty sales; and

WHEREAS, the Auxiliary plans to sell food and other items at the Event and requests that they be allowed to retain all concession revenues; NOW, THEREFORE,

BE IT RESOLVED, by the Council for The City of San Diego, that it hereby waives, on behalf of the City, one-half (1/2) of the revenue it would have received from the sale of the food and novelties at the fundraiser put on by the Children's Hospital Auxiliary on March 24 and 25, 1990, at San Diego Jack Murphy Stadium.
