

RESOLUTION NUMBER R- 275215

ADOPTED ON FEB 26 1990

WHEREAS, on July 27, 1989, the Planning Commission of The City of San Diego initiated an amendment to the Otay Mesa-Nestor Community Plan, hereafter referred to as the Clark Amendment; and

WHEREAS, the initiation met the criteria of Council Policy 600-35, Processing of Community Plan Amendments; and

WHEREAS, Council Policy 600-35 requires the consolidation of community plan amendments for six geographic sectors of the City; and

WHEREAS, the consolidated hearings for the South City sector, in which the proposed Clark Amendment is located, have been scheduled to be heard by the Planning Commission on the first Thursday of February, 1990; and

WHEREAS, Council Policy 600-35 requires that the environmental review for community plan amendments must be finalized at least sixty days prior to the scheduled Planning Commission hearing date; and

WHEREAS, the environmental review was not finalized at least sixty days prior to the scheduled Planning Commission date; and

WHEREAS, the hearing on the Clark Amendment could not occur on the first Thursday of February, 1990; and

WHEREAS, the Clark Amendment was the only community plan amendment scheduled to be heard in the South City sector in 1990; and


WHEREAS, the Council directs that the Planning Commission  
conduct a hearing on the Clark Amendment in May, 1990; and

WHEREAS, the purpose and intent of Council Policy 600-35 will  
be fulfilled; and

WHEREAS, the public health, safety and welfare would be  
served by this direction; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that  
the Planning Commission is hereby directed to conduct a hearing  
on the Clark Amendment on May 17, 1990, unless a continuance  
request is granted at that time.
