BE IT FURTHER RESOLVED, that the City Manager is authorized to secure and execute contracts with the Project Coordinator and various artists to conduct the Chicano Park murals restoration in accordance with the City Manager's Report No. 20-97 and Murals Committee Report, so long as the total amount of the contracts does not exceed \$60,000.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is authorized to expend an amount not to exceed \$60,000 from Fund No. 10270, Dept. No. 1027, Job Order No. 001990, for the purpose of funding the above-described contracts.
