WHEREAS, the Commission for Arts and Culture in its meeting of January 19, 1990 recommended restoring the murals in Chicano Park in accordance with the "Draft Presentation and Recommendations for Restoring and Painting Murals in Chicano Park" presented by the Chicano Park Murals Committee (Murals Committee Report) (copy attached); and

WHEREAS, the City Manager recommends that the City Council adopt the recommendation set forth in the City Manager's Report No. 90-97, dated February 21, 1990, which report is on file with the City Clerk's office; and

WHEREAS, the Council finds it is in the public interest to restore the murals in Chicano Park in accordance with the attached Murals Committee Report; NOW, THEREFORE,

BE IT RESOLVED, that the Council of The City of San Diego approve the recommendations of the Commission for Arts and Culture and the Chicano Park Murals Committee to restore the Chicano Park murals in accordance with the Murals Committee Report.

BE IT FURTHER RESOLVED, that the City Manager is authorized to secure and execute contracts with the Project Coordinator and various artists to conduct the Chicano Park murals restoration in accordance with the City Manager's Report No. 90-97 and Murals Committee Report, so long as the total amount of the contracts does not exceed \$60,000.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is authorized to expend an amount not to exceed \$60,000 from Fund No. 10270, Dept. No. 1027, Job Order No. 001990, for the purpose of funding the above-described contracts.
