RESOLUTION NUMBER R- 275224

ADOPTED ON FEB 27 1990

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO, CALIFORNIA DETERMINING THAT THE PUBLIC INTEREST AND NECESSITY DEMAND THE ACQUISITION AND CONSTRUCTION OR COMPLETION OF POLICE AND FIRE DEPARTMENT AND OTHER PUBLIC SAFETY COMMUNICATIONS AND DISPATCH FACILITIES; AND MAKING CERTAIN OTHER FINDINGS AND DETERMINATIONS IN CONNECTION THEREWITH.

WHEREAS, this Council is in receipt of a report of the City Manager setting forth in detail the needs of the City for the replacement of outdated and overloaded Police and Fire Department and other Public Safety Communications and Dispatch Facilities ("Facilities" herein); and

WHEREAS, said report contains an estimate of the cost of such Facilities, which estimate is \$25,500,000; and

WHEREAS, said cost exceeds the funds available to the City to acquire such Facilities; and

WHEREAS, said report of the City Manager recommends that a measure for incurring indebtedness through the issuance of general obligation bonds of the City be submitted to the voters of the City, at an election to be called and held on June 5, 1990; NOW, THEREFORE,

The Council of The City of San Diego, California, DOES HEREBY FIND, RESOLVE, DETERMINE AND ORDER as follows:

1. That the recitals set forth hereinabove are true and correct in all respects.

2. That pursuant to Section 43607 of the Government Code of California, it is hereby found that public interest and necessity demand the acquisition, construction or completion of municipal improvements for the purpose of replacing outdated and overloaded Police and Fire Department and other Public Safety Communications Facilities including, but not limited to, construction of Police and Fire and other Public Safety Communications Centers and equipment for such centers; a Police Department and Fire Department and other Public Safety computer-aided dispatch system and radio system; and related facilities as necessary to improve the efficiency of 911 emergency phone system and emergency radio systems resulting in reduced Police and Fire Department and other Public Safety response times, and for the payment of all costs and expenses in connection with such replacements and the issuance of such bonds.

3. That the public interest and necessity require that a measure be submitted to the voters on June 5, 1990 for the incurring of bonded indebtedness of the City in the amount of \$25,500,000 for the purpose of providing funds for such replacement of such Facilities.

4. Any resolution of the City and any part of such resolution inconsistent with this resolution is hereby repealed to the extent of such inconsistency.
