BE IT RESOLVED, by the Council of The City of San Diego that the offer of DIATEC POLYMERS, meeting specifications, is hereby accepted and the City Manager is hereby authorized to execute a contract for the purchase of approximately 860,000 LBS OF CATIONIC POLYMER for use at the Metro Wastewater Treatment Plant at a cost of \$0.105 per pound, for a total estimated cost of \$90,300.00; terms net 30 days plus sales tax.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$96,846.75, from Department No. 700, Organization No. 301, Object Account No. 3221, and Job Order No. 2501, is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
