BE IT RESOLVED, by the Council of the City of San Diego that the plans and specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for REMOVAL OF ARCHITECTURAL BARRIERS FOR THE HANDICAPPED - CONTRACT NO. 28, San Diego, California, filed in the office of the City Clerk of the City of San Diego, California, on MAR 12 1990, and bearing official Document No. W.O. 119450, be and the same are hereby approved.

BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for REMOVAL OF ARCHITECTURAL BARRIERS FOR THE HANDICAPPED - CONTRACT No. 28.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$58,500 (\$50,000 from Fund No. 18525, CIP No. 52-243 ARCHITECTURAL BARRIERS REMOVAL - DOWNTOWN AND VARIOUS LOCATIONS CITY-WIDE, and \$8,500 from Fund No. 30245, CIP No. 58-007 ANNUAL ALLOCATION, OVERHEAD COSTS FOR PROJECTS FUNDED BY FEDERAL GRANTS), for purposes of executing this contract and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
