RESOLUTION NUMBER R- 275247

ADOPTED ON MAR 12 1990

WHEREAS, the Associated Students of San Diego State University and the College Area Community Council have joined in a cooperative effort to improve neighborhood relations in the College Area by forming the Good Neighbor Program; and

WHEREAS, representatives from community organizations and City staff, including representatives from Zoning Enforcement, Building Inspection, Noise Abatement, the San Diego Police Department, and the Community Mediation Center, have provided training and information to community volunteers; and

WHEREAS, volunteers have gone door-to-door through targeted sections of the neighborhood to discuss local concerns and zoning laws with area homeowners and students; and

WHEREAS, the Good Neighbor Program has established a Community Hotline in which residents receive immediate attention for concerns or problems in the neighborhood; and

WHEREAS, much leadership and dedication has been demonstrated by the program organizers to restore neighborly cooperation and promote a positive community atmosphere; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council, for and on behalf of said City, hereby commends the College Area Community Council, for establishing the Good Neighborhood Program.

BE IT FURTHER RESOLVED, that this Council urges an ongoing continuation and expansion of this program in improving community relations.
