
RESOLUTION NUMBER R- 275266

BE IT RESOLVED, by the Council of The City of San Diego, that the acceptance by the City Manager of deeds of KEYSTON PACIFIC, INC., a corporation, dated April 20, 1989; RELIABLE STEEL SUPPLY COMPANY OF SAN DIEGO, a California corporation, dated November 13, 1989; and SAMUEL W. BLOCK, Trustee of the Samuel W. Block Revocable Trust, and MARTIN N. GRAHAM and HELENE P. GRAHAM, Trustees of the Martin N. Graham and Helene P. Graham Living Trust, dated November 10, 1989, all executed in favor of The City of San Diego, copies of which deeds are on file in the office of the City Clerk as Document Nos. RR-275266 - 1, RR-275266 - 2 and RR-275266 - 3, granting to said City easements in Lots 3 and 4 of Daley Industrial Park Unit No. 1, Map No. 6439, as more particularly described in said deeds, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street, and the same is hereby named AERO DRIVE.

BE IT FURTHER RESOLVED, that the City Clerk shall cause the deeds and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder at no fee for the benefit of the City, with no documentary tax due.
