

RESOLUTION NUMBER R- 275278

ADOPTED ON MAR 13 1990

WHEREAS, the Planning Commission of The City of San Diego held a public hearing on October 19, 1989, to consider the proposed GREATER NORTH PARK COMMUNITY PLAN amendment for the purpose of redesignating the area bounded by Texas Street to the east, Monroe Avenue to the south, Madison Avenue to the north and Louisiana Street to the west in the northwestern portion of the community; the lots fronting on Meade Avenue, Monroe Avenue and Madison Avenue between Texas Street and Park Boulevard in the northwestern portion of the community; and the area bounded by Landis Street and Myrtle Avenue to the north, both sides of 32nd and 33rd Streets to the west, Boundary Street to the east and Upas Street to the south in the southeastern portion of the community, from low-medium (+) (10-17 units per net acre) density residential, and low-medium density residential (10-15 units per net acre) respectively; and


WHEREAS, the Planning Commission approved and recommended adoption by the City Council of said amendment; and
