RESOLUTION NUMBER R-275285

ADOPTED ON MARCH 19, 1990

WHEREAS, many people continue to die of fire and burn injuries and property in California is lost to fire each year; and

WHEREAS, fire incidents continue the upward trend started in 1987 with 5,000 more fire incidents in 1988; and

WHEREAS, fire costs California over one billion dollars annually in destroyed property and lost natural resources, as well as serious personal trauma and suffering; and


WHEREAS, it is critical that the attention of the public be directed to the causes of the preventable loss of life and property by fire and burn injuries and to the best and most practicable means to control this damage; and

WHEREAS, the California Fire Service has united in its efforts to educate all citizens on fire safety and burn prevention by the implementation of the first statewide campaign to heighten public awareness of good fire safety and burn prevention practices; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council, for and on behalf of the people of San Diego, by and through the Mayor, hereby proclaims the year 1990 to be

"FIRE SAFETY AND BURN PREVENTION YEAR" in San Diego, and urges all citizens to practice fire safety and burn prevention in the home.
