ADOPTED ON MAR 19 1990

BE IT RESOLVED, by the Council of The City of San Diego that the low bid of INTEROX AMERICA, meeting specifications, is hereby accepted and the City Manager is hereby authorized to execute a contract for the purchase of AN ESTIMATED 800,000 POUNDS OF HYDROGEN PEROXIDE as may be required for the period of one (1) year beginning April 1, 1990 through March 31, 1991, at a cost of \$0.3933 per pound, for a total estimated cost of \$314,640.00; terms net 30 days plus sales tax; with an option to renew for one (1) year, with a price escalation not to exceed 5% of the price in effect at the end of the prior year.

BE IT FURTHER RESOLVED that in the event the vendor fails to deliver material in accordance with specifications, authorizing the Purchasing Agent to terminate the contract and to award to the next low bidder, or to obtain material on the open market until the requirement can be rebid.
