RESOLUTION NUMBER R- 275292

ADOPTED ON MAR 19 1990

WHEREAS, San Diego Municipal Code section 22.0210.1 requires that the resolution contain reasons for not accepting the low bid on a landscape maintenance contract; and

WHEREAS, Aztec Landscape is performing poorly on another contract with the City; and

WHEREAS, in January they received a letter from the Park and Recreation Department documenting deficiencies in maintenance of Campus Point; and

WHEREAS, Aztec has also done substandard work in the North City West Maintenance District; and

WHEREAS, since Aztec's performance is deficient on other City contracts, the Purchasing Department and the Police Department feel that it would be unwise to award this contract to Aztec; and

WHEREAS, R.C.'s Landscape currently holds the contract for these police sites, and that company is performing poorly; and

WHEREAS, despite written warnings, R.C.'s Landscape has not brought the areas into compliance with specifications; NOW,
THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, that the low acceptable bid of EVERGREEN LANDSCAPE DESIGN AND CONSTRUCTION, meeting specifications, is hereby accepted and that the City Manager be and he is hereby authorized and empowered to execute, for and behalf of said City, a contract for furnishing

COMPLETE LANDSCAPE MAINTENANCE OF NINE (9) POLICE DEPARTMENT SITES as may be required for a period of ten months beginning March 1, 1990 through December 31, 1990, per prices on file in the Purchasing Department, for an estimated annual total of \$49,000; terms 2% 20 days, with options to renew for four (4) additional one (1) year periods, with a price escalation not to exceed 9% of prices in effect at the end of each prior year.

BE IT FURTHER RESOLVED, that in the event the Contractor fails to perform in accordance with specifications, authorizing the Purchasing Agent to terminate the contract and award to the next low bidder and to subsequent low bidders, if necessary, until a contractor is found who complies with specifications.
