BE IT RESOLVED, by the Council of The City of San Diego that the low bids of 1. COMFORT ZONE AIR CONDITIONING AND HEATING SERVICING. and 2. AIR CONDITIONING TECHNICIANS, INC., meeting specifications, are hereby accepted and the City Manager is hereby authorized to execute a contract for the purchase and installation of EXHAUST SYSTEMS AT FIVE (5) FIRE STATIONS as follows:

1. COMFORT ZONE AIR CONDITIONING AND HEATING SERVICE INC. for Stations 11, 23 and 36 for a total cost of \$32,249.50; plus applicable sales tax of \$2,337.24, terms 1% 20 days.
2. AIR CONDITIONING TECHNICIANS, INC. for Stations 20 and 41 for a total cost of \$23,920; plus applicable sales tax of \$833.76, terms net 30 days.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$59,340.50, (\$34,586.74 from Department/Fund No. 30244, Organization No. 106, Object Account No. 4220 and Job Order No. 330790) (\$12,376.88 from Department/Fund No. 30244, Organization No. 106, Object Account No. 4222 and Job Order No. 330790) and (\$12,376.88 from Department/Fund No. 30244, Organization No. 106, Object Account No. 4222, and Job Order No. 330790) is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advise from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
