



BE IT RESOLVED, by the Council of The City of San Diego that the low bid of AMERON CONCRETE AND STEEL PIPE SO. CALIF. DIV., meeting specifications, is hereby accepted and the City Manager is hereby authorized to execute a contract for the purchase of 2000 FEET OF 27" CONCRETE CYLINDER PIPE AND ALL FITTINGS, for a total of \$95,700; terms net, plus applicable California sales tax.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$102,638.25, from Department No. 700, Organization No. 205, Object Account No. 3316, and Job Order No. 171389, is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
