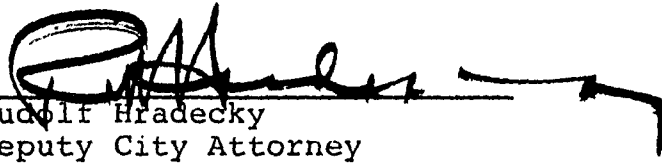

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to exclude from further consideration any proposals for long-haul transport or disposal of waste beyond the corporate limits of the City of San Diego in connection with evaluations of this project.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized and directed to prepare a project development schedule for the activities required to proceed to the point of making

the final project procurement recommendations to the City Council.
