

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to expend \$78,000 (\$50,000 from General Fund 100, Park and Recreation Dept. No. 446, Org. 246, Account No. 4222, Job Order No. 44647; and \$28,000 from the Water Utilities Fund No. 41500, Dept. No. 700, Org. 101, Account No. 4222, Job Order No. 3519), solely and exclusively for the purpose of providing funds for the execution of the above first amendment to the agreement for Fiscal Year 90.
