A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN DIEGO CALLING FOR THE FORMATION OF A PROJECT AREA COMMITTEE FOR THE PROPOSED CITY HEIGHTS REDEVELOPMENT PROJECT AND ADOPTING A PROCEDURE FOR THE FORMATION OF THE PROJECT AREA COMMITTEE.

WHEREAS, the Council of The City of San Diego (the "City Council") by Resolution No. 273594 adopted on May 30, 1989, approved a redevelopment survey area to study and determine the feasibility of a redevelopment project or projects therein; and

WHEREAS, on February 5, 1990, the City Council renamed the Mid-City Redevelopment Project as the "City Heights Redevelopment Project"; and

WHEREAS, the Redevelopment Agency of The City of San Diego
(the "Agency") is preparing a redevelopment plan for the proposed
City Heights Redevelopment Project in accordance with the
California Community Redevelopment Law; and

WHEREAS, pursuant to subdivision (a) of Section 33385 of the Community Redevelopment Law, the City Council shall call upon the residents, businesses and existing community organizations in the project area to form a project area committee; and

WHEREAS, pursuant to subdivision (b) of Section 33385 of the Community Redevelopment Law, the City Council shall, by resolution, adopt a procedure for the formation of the project area committee; and

WHEREAS, the City Council has published and mailed notice of a City Council meeting this date to consider adoption of a proposed "Procedure for Formation of Project Area Committee for the City Heights Redevelopment Project" relative to the formation and selection of the Project Area Committee; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

- 1. The City Council hereby calls upon the residents and existing community organizations in the City Heights

  Redevelopment Project Area to form a project area committee in accordance with the Community Redevelopment Law.
- 2. The City Council hereby adopts as the procedure for the formation of the project area committee, the "Procedure for Formation of Project Area Committee for the City Heights Redevelopment Project" in the form presented to this meeting and placed on file in the office of the City Clerk as Document No. RR- 275331.
