ADOPTED ON MARCH 20, 1990

BE IT RESOLVED, by the Council for The City of San Diego, that the design/build competition for the new Civic Center be put on hold.


BE IT FURTHER RESOLVED, by the Council, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with Gruen Gruen & Associates, to conduct a reuse and redevelopment study for the Community Concourse, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- 275340 .

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed one hundred thousand dollars (\$100,000) is hereby authorized, solely and exclusively for the purpose of providing funds for the above project, with those funds coming from the following sources: thirty-five thousand dollars (\$35,000) from the Centre City Development Corporation's carry-over funds related to Concourse reuse; twenty thousand dollars (\$20,000)

from nondepartmental and forty-five thousand dollars (\$45,000)
from CIP (Civic Center) to J.O. 372201, Fund 41301.
