ADOPTED ON MARCH 20, 1990

BE IT RESOLVED, by the Council of The City of San Diego, that pursuant to authority conferred by and in accordance with the provisions of Section 86.04 of the San Diego Municipal Code, a PARKING TIME LIMIT OF TWO HOURS, be and the same is established on Bernardo Center Drive between I-15 and Rancho Bernardo Road in the Rancho Bernardo Community. Notwithstanding the provisions of Section 86.01 this parking limitation shall be in force on nonenforcement days.

BE IT FURTHER RESOLVED, that the installation of the necessary signs and markings be and the same is hereby authorized to be made on said street, and the regulations hereinabove imposed shall become effective upon the installation of such signs.
