WHEREAS, on August 9, 1989, the City Council and Board of Supervisors approved a Memorandum of Understanding (MOU) regarding jails and courtrooms; and

WHEREAS, the MOU states that the City will provide the County with a 25-40 acre site so that the County can build a permanent 700 bed pre-trial detention facility; and

WHEREAS, the County will pay City for the fair market value of the site from Proposition A (1 cent sales tax) funds or funds from a subsequent tax measure necessary to finance jail construction; and

WHEREAS, the City site currently under consideration is the 40 acre Sander site which is part of the Navy-City land exchange; and

WHEREAS, to expedite the construction of the pre-trial detention facility, the County has engaged the services of Woodward-Clyde to do a "fatal-flaw" study of the Sander site for hazardous waste or other unsuitable conditions which will cost \$111,494; and

WHEREAS, the Board of Supervisors has approved this contract and the appropriation of the necessary funding; and

WHEREAS, the Board has requested that if the site is found to be unsuitable that the City reimburse the County for 50% of its costs; and

WHEREAS, because this study would be necessary in any event for the City to properly develop and market this property, the City Manager recommends approval; and

WHEREAS, fiscal impact will be approximately \$56,000 if the site is found to be unsuitable as a jail site; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Auditor and Comptroller is hereby directed to reimburse the County of San Diego for 50% of its costs related to an environmental study of the Sander site if said study reveals that the site cannot be used for a pre-trial detention facility.
