
ADOPTED ON MAR 26 1990

BE IT RESOLVED, by the Council of The City of San Diego, that the acceptance by the City Manager of a street easement deed of TREVI MEDICAL PLAZA, LTD., a California limited partnership, executed in favor of The City of San Diego, bearing date of October 19, 1989, a copy of which deed is on file in the office of the City Clerk as Document No. RR- 275366, granting to said City an easement for public street purposes in a portion of Lot 13, Block 9 of Fifth Street Addition, Map No. 577, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street, and the same is hereby named LEWIS STREET.

BE IT FURTHER RESOLVED, that the City Clerk shall cause the deed and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder at no fee for the benefit of the City, with no documentary tax due.
