RESOLUTION NUMBER R- 275372

ADOPTED ON MAR 26 1990

WHEREAS, the City of San Diego is implementing a public arts program entitled City Gates Program under San Diego Municipal Code section 26.0701 et seq.; and

WHEREAS, the City Gates Program consists of seven large-scale, freeway related and site-specific urban activities; and

WHEREAS, the City Gates Program was originally spearheaded by the City's Public Arts Advisory Board, in cooperation with the City's Park and Recreation Department, who developed a City Gates Master Plan, and in cooperation with the State of California Department of Transportation; and

WHEREAS, the City's Commission for Arts and Culture, successor to the Public Arts Advisory Board (PAAB), endorsed the City Gates Program in August 1988; and

WHEREAS, in 1988 the City decided as an initial step to pursue design and development of two of the seven gates, North Gate (Ardath Road) and South Gate (Barrio Station/Chicano Park); and

WHEREAS, in 1988 and 1989 an open competition was held to select artist/design teams to compete for the opportunity to develop detailed designs for North and South Gates; and

WHEREAS, in August 1989 the City Manager executed contracts with eight (8) artist/design teams in the amount of \$5,000 each to develop detailed plans for North and South Gates; and

WHEREAS, in December 1989 a selection jury chosen by PAAB and approved by the Commission for Arts and Culture (Commission) convened to review the eight proposals using the following criteria: 1) artistic merit; 2) feasibility of design concept; 3) relationship to site, community, and the City Gate Master Plan; 4) maintenance requirements; and, 5) safety; and

WHEREAS, the jury recommended artist Ellen Phillips for North Gate and the artist/architect team of Brailsford/Chacon/Salas for South Gate; and

WHEREAS, the Commission adopted the jury's recommended artist and artist/architect team at their December 15, 1989 meeting; and

WHEREAS, the Public Services & Safety Committee adopted the Commission's recommendation on February 21, 1990; and

WHEREAS, City funds to implement construction of the North Gate and South Gate projects are currently not available; and

WHEREAS, the Commission intends to raise the necessary funds to construct both gates (\$150,000 for North Gate and \$200,000 for South Gate) through state and federal grants and private endorsement; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego that the Commission's and Public Services and Safety Committee's recommendations with respect to selection of artist Ellen Phillips for North Gate and artist/architect team Brailsford/Chacon/Salas for South Gate, be adopted.

BE IT FURTHER RESOLVED, that the Commission for Arts and Culture be encouraged to pursue funds to construct North Gate and South Gate through federal and state grants and private endorsements.
