
RESOLUTION NUMBER R- 275379

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with DLSK PROFESSIONAL ENGINEERS, to provide consultant services for City's Police Communications Dispatch Center, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- 275379.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$97,900 from CIP 33-095.0 Police and Fire - Communications Project, Capital Outlay - Other Revenue Fund 302453 for this and related purposes, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.

BE IT FURTHER RESOLVED, that based upon the recommendations of the City Manager, the provisions of Council Policy 300-7 are hereby waived regarding the selection of this consultant.
