
BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, Amendment No. 4 to the agreement of December 7, 1987, with Black & Veatch, under the terms and conditions set forth in Amendment No. 4 on file in the office of the City Clerk as Document No. RR- 275393, together with any reasonably necessary modifications or amendments thereto which do not increase project scope or cost and which the City Manager shall deem necessary from time to time in order to carry out the purposes and intent of this project and amendment.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$218,153.00 from CIP No. 46-147.0, Modified Wastewater Treatment Facilities Plan, is hereby authorized, solely and exclusively for the purpose of providing funds for the above amendment.

BE IT FURTHER RESOLVED, that if circumstances warrant, the City Manager is authorized to finance or refinance this project with tax exempt securities.
