WHEREAS, the purpose of the Graffiti Removal Improvement Program is to eliminate graffiti from neighborhoods that are subject to vandalism and gang activity; and

WHEREAS, the Graffiti Removal Improvement Program's prime objective is to assist property owners in painting out graffiti as soon as they see it in their own neighborhoods; and

WHEREAS, graffiti was painted out in the following communities: Jamacha, Lomita, Skyline, Paradise Hills, North Bay Terraces, South Bay Terraces, South Encanto, Valencia Park, Alta Vista, Emerald Hills, Lincoln Park and Chollas View; and

WHEREAS, Dr. Dalton Lee's Public Administration Class at San Diego State University volunteered their assistance to coordinate and implement the Graffiti Removal Improvement Program for the aforementioned communities; and

WHEREAS, on March 17, 1990, Dr. Dalton Lee's Public Administration Class rallied the community and collectively attracted nearly 200 participants to support the Graffiti Removal Improvement Program; and

WHEREAS, those participants painted or made donations to the program for needed manpower, supplies, refreshments and entertainment; and


WHEREAS, the fruits of Dr. Dalton Lee's Public Administration Class' labor resulted in removing approximately fifty percent of

the graffiti in these communities; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council hereby congratulates Dr. Dalton Lee's Public Administration Class in making the Graffiti Removal Improvement Program a success and further commends their volunteer efforts and dedication to the task of promoting this program as a community project.
